


CORRIGENDUM

This is with reference to the Request for Expression of Interest (REOI) dated 25 April 2018 issued by Directorate of Industries, Government of Uttarakhand for 'Selection of Knowledge Partner for Investment Promotion and Investor Facilitation Support to Government of Uttarakhand'.

		2. Request to consider ongoing projects as well	Only those ongoing projects would be considered wherein the Global Investment Summit has been successfully completed.

Request to consider projects both for State Governments as well as Central Government	As this is shortlisting criteria, and the intention was to have multi-sector state-level Global Investment Summit, experience with state governments only will be considered. During RFP state, the Department may consider to provide scoring weightage for projects with Central Government also.
		4. Request to increase project period to be taken into consideration from 3 years to 5 years	As per Serial No. 1
